Regulatory Alert - Colombia

Resolución 711 of 2016 issued – truncation of 900MHz band from 902-928MHz to 915-928MHz

Further to PCS' Regulatory Update issued on 19th April 2016, Resolution 711, 2016 has been officially released via the website of Colombian National Spectrum Agency, *Agencia Nacional del Espectro* (ANE).

The resolution confirms the truncation of the use of the 900MHz band in Colombia from 902-928MHz to 915-928MHz, for the operation of WAS/RLAN devices (e.g. UHF RFID), shortrange devices, and wireless telephones, amongst others.

A summary of the maximum permitted output powers for each type of device is shown below:
