India – BIS Safety Approval Scheme Expansion – Phase III

Electronics and Information Technology Goods (Requirements for Compulsory Registration) Order, 2012

Following PCS' Regulatory Update issued on 20th of February 2017, The Department of Electronics and Information Technology (Deity) in India has now expanded the scope of product categories included in the Electronics and Information Technology Goods (Requirements for Compulsory Registration) Order, 2012.

The Bureau of Indian Standards (BIS) will publish a notification in the Gazette of India to include 13 new product categories for coverage under Compulsory Registration Order (CRO). Manufacturers of products included within these new categories will then be required to meet BIS requirements six months from the date of publication of this notification in the Gazette. A confirmed publication date in the Gazette is unknown at this stage.

The only change is the addition of 13 new product categories under CRO. The processes and procedures for BIS registration remains the same.

A list of the 13 categories which have been added to the CRO are included as an appendix to this Regulatory Alert.
