Regulatory Update

Vietnam – Energy Efficiency Circular 36/2016/TT-BCT issued to replace current Circular 07/2012/TT-BCT

On December 28, 2016, the Ministry of Industry and Trade (MOIT) in Vietnam issued new Circular 36/2016/TT-BCT to replace the current 07/2012/TT-BCT dated April 4, 2012 in respect of regulations on Energy Efficiency (EE), and it will take effect on 10th February 2017.

Main changes between Circular 36/2016/TT-BCT and Circular 07/2012/TT-BCT are indicated in the table below:

Circular 36/2016/TT-BCT		Circular 07/2012/TT-BCT
EE certificate could be obtained before	vs	EE certificate can only be applied after
import start		each import batch arrives in Vietnam
EE test reports issued by either accredited local labs or foreign labs with ISO/IEC 17025 accreditation recognized by ILAC or APLAC accepted	vs	Only the EE test reports issued within 6 months from the testing date by accredited local labs can be accepted.
EE test reports and EE certificate issued for the model can be used for all import batches of the model	vs	EE test reports and EE certificate must be obtained for each import batch

PCS will be able to support customers in obtaining EE certification under new Circular 36/2016/TT-BCT after 10th February 2017. Before that, all requirements and process still remain unchanged as per current Circular 07/2012/TT-BCT.

The list of products requiring EE certificate can be found in attached annex.

Documentation required for EE certification are as follows:

1) EE test reports

- 2) Technical specification
- 3) Drafted energy label of the local importer to be pasted on the product
- 4) Notarized copy of the business license of the local importer
- 5) Application form to be signed by the local importer



Lead-time for obtaining EE certificate is around 10 working days from submission of the application (not including local testing time if required). Timescale for local testing varies from products and local labs.

EE certificates issued under new Circular 36/2016/TT-BCT do not expire.
