What you need to know about organic certification

The terms "organic" and "eco" in food are legally protected terms. When using these terms, it should be ensured that they are also used in accordance with the law. Consumer protection, fair competition and transparency are important aspects and are ensured by inspections.

Therefore any company that produces organically processed or unprocessed agricultural or organic seed, or that processes organic agricultural products as food or feed, must be certified to sell the products in their target markets.

Your way to organic certification

- Inquiry: Ask Kiwa BCS for a certification.
 You can enter your data in our application form to receive a quotation.
- Quotation: After checking the application form, an offer without obligation will be sent to you.
- Contract and further process: Once you have accepted our offer and signed the inspection contract, you will receive an appointment for the initial inspection. At the same time you will receive further documents from us in order to be well prepared for the initial inspection.
- Initial inspection: On the day of the initial inspection, the compliance with the requirements of the organic guidelines will be checked by one of our inspectors. This will take place in your factory through file review, site tour and interview.
- Certificate: Upon fulfilment of all requirements, you will receive the certificate from us. Organic products may now be marketed as such.
- **Follow-up inspections:** The inspections are carried out regularly, at least once a year on site.
