India – BIS Safety Approval Scheme Expansion

Electronics and Information Technology Goods (Requirements for Compulsory Registration) Order, 2012

The Department of Electronics and Information Technology (Deity) in India has announced an expansion to the scope of (to include new products to) the Electronics and Information Technology Goods (Requirements for Compulsory Registration) Order, 2012.

It is previously said when the newly adopted scope expansion notification is published in the Gazette, manufacturers will likely have 6 months to comply.

It is now confirmed in the Gazette dated 13th November 2014 that the inclusion of new products are to come into force in two timelines:

- 1. All new products except batteries 13th May 2015
- 2. Batteries 13th August 2015

Significance of inclusion of new products is as follow:

- 1. Power adapters and batteries the inclusion refers to are the ones that will be imported independently and / or will be used with products not covered by the mandatory registration.
- 2. Magnetic stripe readers are not considered to be smart card readers.
- 3. The category of mobile phones is expected to be wide and include many enterprise products that support cell phone technology/functionality. We expect Deity will make further clarification on which product types are and are not considered to be included within the new scope.



The only change to the BIS approval system is the increased scope of product types that the scheme applies to. The processes and procedures of BIS approval have not been changed.
